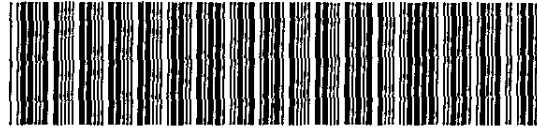

**ARTICLE I - NAME**

The name of this corporation BUSTER CONSTRUCTION, INC.

**ARTICLE II - PURPOSE**
