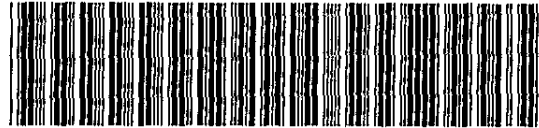

ARTICLES OF INCORPORATION
OF

FLORIDA PHYSICIANS RECRUITERS, INC

The undersigned acting as incorporator of a Corporation pursuant to Chapter 607, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLE I. NAME

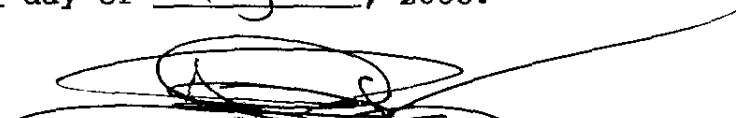

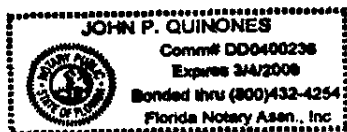

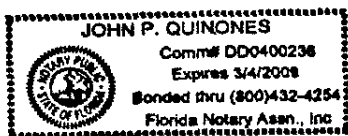
