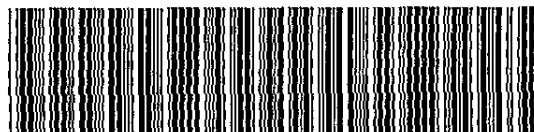

AMENDMENT




