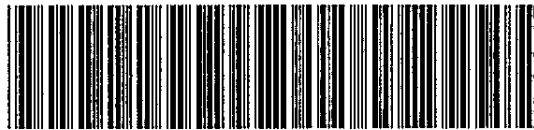

Article I
Identification

The name of the corporation, hereinafter referred to as the "Corporation," is Charles Plumber Inc.




