ARTICLES OF INCORPORATION OF

NATURAL ENVIRONMENTAL TECHNOLOGIES, INC.

The undersigned, acting as incorporator hereby forms a corporation for profit pursuant to Chapter 607 of the Florida Statutes and adopts the following Articles of Incorporation for such Corporation:

ARTICLE 1 - NAME OF CORPORATION

The name of this Corporation shall be NATURAL ENVIRONMENTAL TECHNOLOGIES, INC..

ARTICLE II - PURPOSE

The general purpose for which this Corporation is organized shall be to manufacture and distribute environmentally safe, non-toxic products for targeted industries and to conduct and transact any and all lawful business authorized or not prohibited by Chapter 607 of the Florida Statutes, as the same may be from time to time amended.

ARTICLE III - PRINCIPAL OFFICE

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock that this Corporation is authorized to issue and have outstanding at any one time is Ten Thousand (10,000) shares of common stock having a par value of One Dollar (\$1.00) per share.
