OS MAY 12 PH 2:37 The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

## Article I Name

Name. The name of this corporation shall be FOR HELP, INC. Section 1.1

### Article II Principal Office and Mailing Address

Section 2.1 Principal Office and Mailing Address. The initial principal place of business and mailing address of this corporation shall be 1548 LANCASTER TERRACE, JACKSONVILLE, FLORIDA 32204.

### Article III Capital Stock

- Section 3.1 Capital Stock. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$0.10 per share.
- Restriction on Transfer of Stock. The shareholders may, by bylaw provision, by shareholders' agreement recorded in the minute book or by endorsement on each stock certificate, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
- Approval of Shareholders Required for Merger. The approval of the Section 3.3 shareholders holding sixty percent (60%) or more of the capital stock of this corporation eligible to vote to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
