5. This Affidavit is being prepared solely for the purpose of evidencing the ownership of both entities by the same person.

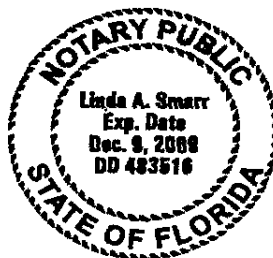


ARTICLE EIGHT - BY-LAWS
