ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is SOUTH FLORIDA COMPUSMART INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence, unless somer dissolved in accordance with the laws of the State of Florida. Corporate existence shall commence at the time of the filing of the articles by the Department of the State, State of Florida.
