



## ARTICLES OF INCORPORATION OF TRI-COUNTY CUSTOM CRAFT, INC.

#### ARTICLE L NAME

NAME: The name of this corporation is TRI-COUNTY CUSTOM CRAFT, INC.

#### ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 15th day of May, 2006.

#### ARTICLE III. NATURE OF BUSINESS

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of (\$1.00) par value common stock.

#### ARTICLE V. PREEMPTIVE RIGHTS
