

## ARTICLES OF INCORPORATION OF BRACXX, INC.



#### Article 1

Name. The name of this Corporation is BRACXX, INC.

#### Article II

<u>Principal Office</u>: The principal place of business and mailing address of this corporation shall be: 15500 S.W. 15<sup>th</sup> Avenue Newberry, Florida, 32669.

#### Article III

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.
