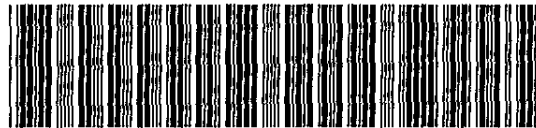

I, the undersigned incorporator, being of full age, do here by associate for the purpose of becoming a corporation under the provision of chapter 607, Florida statutes, 1981, and I hereby accept all the rights, privileges, benefits and obligations conferred and imposed by said law and I do hereby make, subscribe and acknowledge and file these Articles of Incorporation.

ARTICLE 1 - NAME

The Name of this corporation shall be W.NOLAN ENTERPRIZES, INC.

ARTICLE 2 - NATURE OF BUSINESS

The General nature of the business to be transacted and carried on by this corporation and its objects and purposes are to do any and all things herein after set out or provided and it shall have and exercise all the powers conferred by the laws of the State of Florida upon business corporations as fully and to the same extent as natural persons might or could do in all parts of the world, namely, to engage in the business of Engineering and manufacturing consulting and construction subcontracting, expedient, ancillary, or in the aid to the accomplishment of the foregoing: to engage in any manner of business involving the ownership, construction, improvement, sale, lease, mortgage or encumbrance, and investment of real estate; the manufacture, sale, barter, pledge, loan, mortgage or other encumbrance, owing, renting, leasing, receiving and delivery of any and all types, varieties and kinds of personal property, goods, wares and merchandise whether new or used, and the shipping, transporting, warehousing, packing, crating, storing, insuring, bonding, claiming and transferring of the same; to act as agent, broker or factor concerning and transactions in real or personal properties; and to do any such act either within the state of Florida or the UNITED STATES OF AMERICA, and to do each and everything necessary, convenient, suitable or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects enumerated, or which shall at any time appear conducive to or expedient for the protection or benefit of the corporation.
