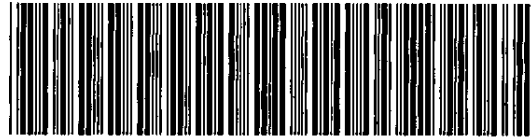



ARTICLE X - SUBCHAPTER S


