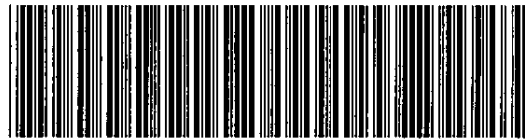

ARTICLES OF INCORPORATION OF ARROWHEAD FOUNDATIONS & FRAMING, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLES I

NAME AND ADDRESS

The name of the corporation shall be ARROWHEAD FOUNDATIONS & FRAMING, INC., principal office, if known, or the mailing address of the corporation is 2825 Hwy 182, Jay, Florida 32565-7230.
