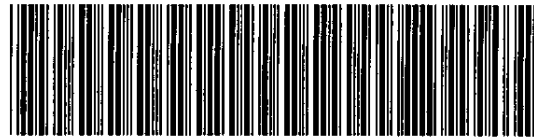

# ARTICLES OF INCORPORATION

Of

General Provisions

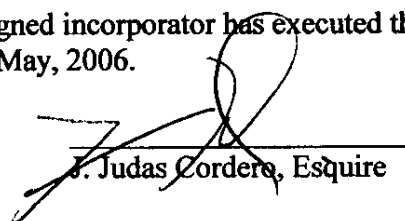

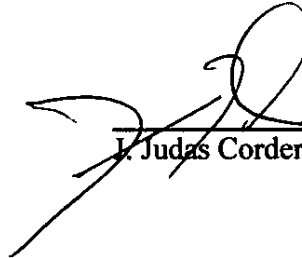
