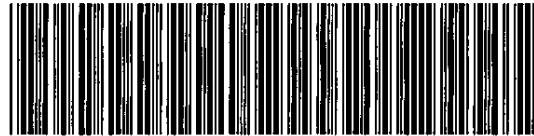

**ARTICLE I  
Name of Corporation**

The name of this corporation is **Enterprises Commercial Francois , Inc.**
