ARTICLES OF INCORPORATION For CARGON, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is CARGON, Inc. Principal place of business is 8961 Lake Park Circle North, Davie Florida 33328

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles.

The duration of the Corporation is perpetual.
