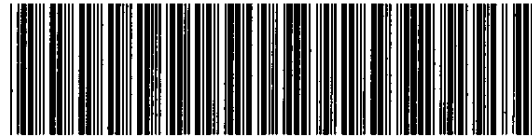


BY-LAWS


