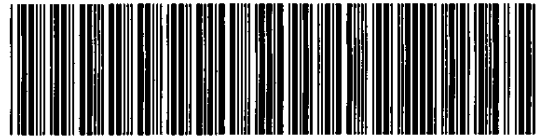


- FIRST: The name of this corporation is **GAL CONSULTANTS, INC.**




