ARTICLES OF INCORPORATION OF SOUTHEAST SLEEP CONSULTANTS, INC.

The undersigned, desiring to form a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is: Southeast Sleep Consultants, Inc.

ARTICLE II: PRINCIPAL OFFICE OR MAILING ADDRESS

The principal office of the corporation is located at and the mailing address of the corporation is 1125 N. Summit Street, Crescent City, Florida, 32112.

ARTICLE III: CAPITAL STOCK

- (a) <u>Authorized Shares</u>. The total number of shares that may be issued by the corporation is 1,000, all of which shall be of the same class, shall be of the par value of \$1.00 per share, and shall be designated common stock.
- (b) <u>Capital Stock</u>. The capital of the corporation shall be at least equal to the sum of the aggregate par value of all issued shares having par value, plus such amounts as, from time to time, by resolution of the Board of Directors, may be transferred thereto.
- (c) <u>Corporate Liquidation and Dissolution</u>. In the event of voluntary or involuntary liquidation, dissolution or winding up of the corporation, the holders of record of the common stock shall be entitled to receive distribution, ratably, of the remaining assets of the corporation.
- (d) <u>Voting</u>. Each share of common stock shall have equal and full voting powers and rights, and the holders of record thereof shall be entitled to one vote per share so held. At all meetings of shareholders, a majority in number of shares entitled to vote at such meeting, present either in person or represented by proxy, shall constitute a quorum.
 - (e) <u>Preemptive Rights</u>. Shareholders shall have no preemptive rights.
 - (f) Cumulative Voting. Cumulative voting shall not be permitted.
 - (g) Restrictions on Transfer of Stock. The shareholders may, by bylaw or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.

ARTICLE IV: INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1125 North Summit Street, Crescent City, Florida 32112, and the name of the initial registered agent of this corporation at that address is William E. Butler.

ARTICLE V: INCORPORATOR

The name and street address of the incorporator of this corporation is:

ARTICLE VI: DIRECTORS

- (a) <u>Number</u>. The corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by bylaws adopted by the shareholders.
- (b) <u>Initial Board of Directors</u>. The name and address of the initial director until the first annual meeting of the shareholders is as follows:

- (c) <u>Compensation</u>. The Board of Directors is hereby specifically authorized to make provision for reasonable compensation to its members for their services as directors, and to fix the basis and condition upon which such compensation shall be paid. Any director of the corporation may also serve the corporation in any other capacity and receive compensation therefore in any form.
- (d) <u>Indemnification</u>. The Board of Directors is hereby specifically authorized to make provision for indemnification of directors, officers, employees and agents to the full extent permitted by law.

The initial Bylaws of this corporation shall be adopted by the directors.
