I, THE UNDERSIGNED, being desirous of associating myself for the purpose of becoming a corporation for profit under the laws of the State of Florida, do make, subscribe, and acknowledge these Articles of Incorporation, pursuant to Section 55 of the Florida General Corporation Act, and other applicable provisions of the Corporation Law of the State of Florida, and acts amendatory thereof and supplemental thereto.

**FIRST:** The name of this Sub Chapter S corporation is **ENHANCED COMPUTERS, INC.**

**SECOND:** The period of duration of the corporation is perpetual.

**THIRD:** The purpose of the corporation shall be to engage in any lawful act or activity for which corporations may be organized under the corporation laws of this State.

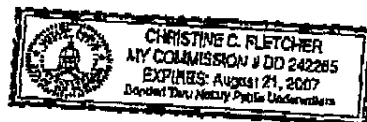

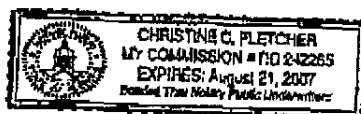
