**ARTICLES OF INCORPORATION
OF
THE WORKROOM OF ALBERTINI AND FORD, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following articles of incorporation:

ARTICLE I

The name of this Corporation is: THE WORKROOM OF ALBERTINI AND FORD, INC.

ARTICLE II

NATURE OF BUSINESS: The general nature of the business to be transacted by this corporation is:

Section 1: To engage in any lawful business, including but not limited to, ownership and operation of projects, ventures and investments including production and sale of custom drapes, window treatments, pillows, bedspreads and any custom sewing or embroidering and including the sale of materials soft and hard goods, retail and wholesale, interior decorating and all things related to the trade.

Section 2: To carry on such other business or activities as may be necessary, convenient or desirable to accomplish the above purposes, and to do all other things incidental thereto which are not prohibited by law or by these Articles of Incorporation.

ARTICLE III

CAPITAL STRUCTURE:

The aggregate number of shares which the corporation is authorized to issue is 1000 shares. The shares will be of a single class.


ARTICLE VIII

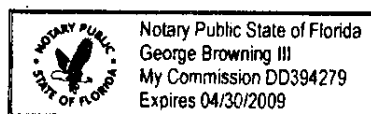
