

We, the undersigned, in compliance with Chapter 607 of the Florida Statutes, submit the following **ARTICLES OF INCORPORATION** for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation is **JOHN J. ALTIERI, M.D., P.A.**

ARTICLE II

The principal place of business and mailing address of this corporation is 3050 Bee Ridge Road, Suite B, Sarasota, Florida.

ARTICLE III

The general purpose of this corporation is to engage in the provision of medical services, and to transact any or all lawful business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.

ARTICLE IV

This corporation shall exist perpetually, and shall commence upon the filing of these **ARTICLES OF INCORPORATION** by the Department of State of the State of Florida.

This corporation reserves the right to amend, alter, modify or repeal any provisions contained herein by a simple majority vote of all voting members of the corporation.


ACKNOWLEDGMENT AND ACCEPTANCE OF REGISTERED AGENT
