ARTICLES OF INCORPORATION

SECRETARY OF STATE WE, the undersigned, hereby associate ourselves together for the purpose of becoming a Corporation under the Laws of the State of Florida and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit, generally and hereby make, subscribed, acknowledge and file this Certificate for the purpose of becoming a Corporation under the laws of the State of Florida.

<u>ARTICLE I</u>

Name of the Corporation

The name of this Corporation shall be CRUZ PAINT & BODY SHOP, INC.

ARTICLE II

Nature of Business

The general nature of the business to be transacted by this Corporation is: Any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

The maximum number	of shares of capital stock authorized to be issued by this
Corporation shall be	10 shares, each having a par value of\$ 50.00

Term of Existence
