ARTICLES OF INCORPORATION OF JUSTIN JENKINS ENTERPRISES, INC.

ARTICLE I

Name and Duration

The name of the Corporation is Justin Jenkins Enterprises, Inc. The duration of the Corporation is perpetual. This Corporation shall begin its corporate existence as of the date that these Articles are filed with the Secretary of State.

The power to adopt, amend or repeal bylaws for the management of this Corporation shall be vested in the Board of Directors or the shareholders, but the Board of Directors may not amend or repeal any bylaw adopted by the shareholders if the shareholders specifically provide that such bylaw is not subject to amendment or repeal by the Board of Directors.

Transfer of Shares
