ARTICLES OF INCORPORATION OF BASS CONSTRUCTION SERVICES, INC.

ARTICLE I: The name of this corporation is EASS CONSTRUCTION SERVICES, INC.

ARTICLE II: This corporation shall have perpetual existence.
