ARTICLES OF INCORPORATION
OF

"CIRCO RECORDS, INC."

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of this Corporation shall be:
CIRCO RECORDS, INC.

ARTICLE II

This Corporation shall commence its existence on the date of filing and shall exist perpetually thereafter unless or until sooner dissolved according to Law.

ARTICLE III

The purpose of this Corporation is to engage in the business of music and to engage in any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV

The Corporation shall be authorized to issue one hundred (100) shares of all one class at one dollar (\$1.00) par value.

ARTICLE V

Every shareholder, upon the sale for cash of any outstanding shares of stock or upon the issuance of any new common stock of this corporation, shall have the right to purchase their pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or an amendment hereto, and any right conferred upon the shareholders is subject to this reservation.
