ARTICLES OF INCORPORATION

OF

"CIRCO RECORDS. LYC."

The undersigned, acting as incorporators of a corporation under the Florida General Corporation.

Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of this Corporation shall be:

CIRCO RECORDS, INC.

ARTICLEII

This Corporation shall commence its existence on the date of filing and shall exist perpetually thereafter unless or until sooner dissolved according to Law.

ARTICLEUL

The purpose of this Corporation is to engage in the business of music and to engage in any other activity or business permitted under the laws of the United States and the State of Florida.

ARTICLEIV

The Corporation shall be authorized to issue one hundred (100) shares of all one class at one dollar (\$1.00) par value.

ARTICLEV
