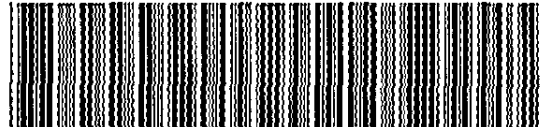

Article I – Name

The name of this corporation is: FRY'S PROFESSIONAL GRADING & BACKHOE SERVICE, INC.

Article II – Duration

This corporation shall have perpetual existence.

Article III – Purpose

The purpose of this corporation shall be to provide grading and backhoe services and any lawful business not prohibited by the laws of the State of Florida or the United States of America.



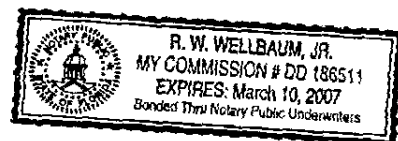
