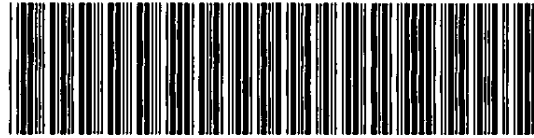

ARTICLES OF INCORPORATION FOR

The undersigned incorporators adopt the following articles of incorporation for the above referenced Corporation:

ARTICLE I

The name of the corporation is "**CHIROPRACTIC PAIN TREATMENT  
CENTER 2, INC**"

ARTICLE II

PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is: 2721 South US 1 Street 20 Fort Pierce FL – 34982. The name of the initial registered agent of the corporation, located at that office, is: Regiane Luna.

ARTICLE III

DURATION

The period of the corporation's duration shall be perpetual, or until dissolved on a vote of the shareholders as provided in these articles.

ARTICLE IV

ARTICLE V

CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 100 shares. These shares shall be of a single class of common stock

and have beginning value of \$ 100.00 per share.

#### CAPITALIZATION

The amount of capital with which the corporation will begin to operate is not less than \$100.00.

#### ARTICLE VII

#### CORPORATE POWERS

The corporation shall have all the rights and powers now or subsequently conferred on corporations by the laws of the State of **Florida**, including, but not limited to, the following: buy and sell stock, property, etc.

#### ARTICLE VIII

#### INCORPORATORS

#### ARTICLE IX

#### DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is one, and the names and addresses of the initial directors is: Regiane Luna 2721 South US 1 Street 20 Fort Pierce Florida, 34982.

The initial directors shall hold office until their successors are elected and qualified as provided in the by laws. The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be the authorized number of directors until that number is changed by a by law duly adopted by the shareholders.

## ARTICLE X

### BY LAWS

The initial directors shall submit the proposed by laws to the shareholders at a meeting to be held for that purpose not more than 10 days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by affirmative vote, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

## ARTICLE XI

### DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two-thirds of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.

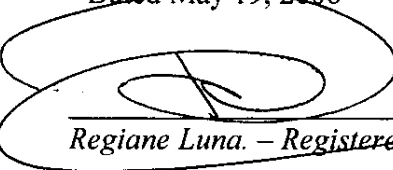
