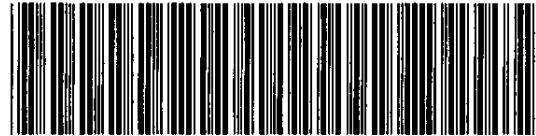

The name of the corporation is SCRIBE, INC.
