The business and affairs of this corporation shall be managed by a board of directors that shall be elected by the shareholders and serve as provided in the Bylaws.

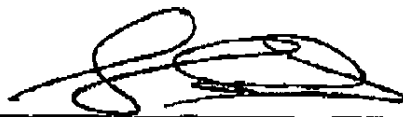
