ARTICLE I NAME

The name of the corporation shall be ACCRUE PLANNING AND LAND USE SERVICES, INC.

ARTICLE II PRINCIPAL OFFICE

The address of the principal office of the corporation is 2814 West 15th Street, Suite 2, Panama City, Florida, 32401.

ARTICLE III DURATION

The corporation shall have perpetual existence, commencing on the date of execution and acknowledgement of these Articles or upon filing.

ARTICLE IV PURPOSE


The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.


