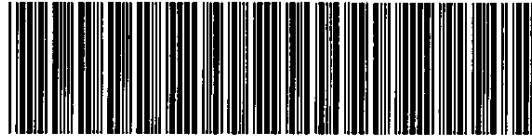

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of this corporation is J & C CUDA CORP., with its principal office located at 336 South Lakeview, Lake Helen, FL 32744.

**ARTICLE II**

This company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.

**ARTICLE III**

The general nature of the business to be transacted by this corporation is as follows:

(a) To transact any and all lawful business for which companies may be organized under the laws of the State of Florida.

(b). To own and operate pizzeria/restaurant business and enter into all contracts and business relationships consistent with this purpose.

(g). To lend money for its business purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.

(h). To conduct its business, carry on its operations, and have offices and exercise the

powers granted by this act within or without this state.

(i). To make distribution for the public welfare or for other charitable, scientific or educational purposes.

(j). To pay pensions and establish pension plans, profit sharing plans, stock bonus plans, stock option plans and other incentive plans for any and all of its directors and officers.

(k). To be a promoter, incorporator, partner, member, associate or manager of any corporation, partnership, joint venture, trust or other enterprise.

(l). To have, exercise and enjoy all of the rights and privileges of companies for profit as conferred by the laws of the State of Florida, it being expressly provided that the enumeration of the specific powers and purposes shall not be held to limit or restrict in any manner the general powers of the company.
