ARTICLES OF INCORPORATION OF SECRETARY OF STATE W.M.C. WOODWORK INC. TALLAHASSEE, FLORIDA

The undersigned subscriber to these Articles of Incorporation is a Natural Person competent to contract and hereby form a Corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE I - NAME

The name of this corporation is W.M.C. WOODWORK INC (Hereinafter, "Corporation")

ARTICLE II - DURATION / TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of the filing of theses Articles which the Department of State.

ARTICLE VII AMENDMENT

These articles of Incorporation may be amended in the manner provided by law.
