### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

#### H.E. HUNT & ASSOCIATES, INC.

 The following provisions of the Articles of Incorporation of H.E. HUNT & ASSOCIATES, INC., a Florida corporation, filed with the Florida Department of State, on May 30, 2006, are amended in the following particulars:

Article VIII is deleted in its entirety and the following inserted in lieu thereof:

#### ARTICLE VIII. DIRECTOR AND OFFICERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under, the direction of its Board of Directors, subject to any limitation set forth in these Articles of Incorporation and the corporation's Bylaws. The corporation shall have one (1) director. The corporation may make changes to its officers and directors from time-to-time as provided in its Bylaws.
