ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of 3amigos Travel, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

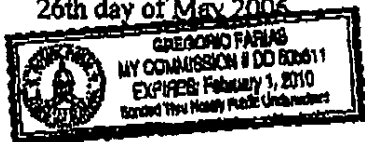
