ARTICLES OF INCORPORATION OF

A-R KENTUCKY PROPERTY CORPORATION



The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be as follows:

A-R KENTUCKY PROPERTY CORPORATION

The principal place of business of this corporation shall be 5070 N. Highway A-1-A, Suite 200, Vero Beach, Florida 32963, and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation shall be formed for the specific purpose of acquiring, holding, and disposing of real and personal property and may in addition engage in or transact any and all lawful activities or business permitted under the laws of the United States; of the State of Florida; or of any other state, country, territory, or principality.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having One and No/100 (\$1.00) Dollar par value per share.

ARTICLE IV. ADDRESS
