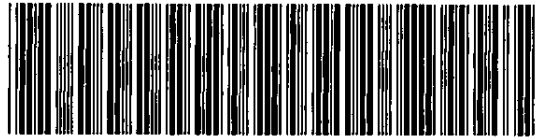

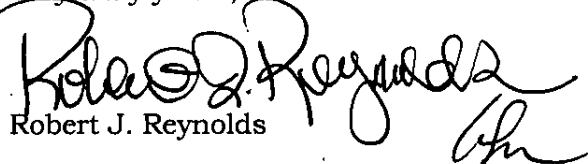

THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**Article I - Name**

The name of the corporation is:

West Florida Sportfishing, Inc.

**Article II - Location and Mailing Address**

The primary location of the corporate office and its mailing address is:

7571 North Galt Point, Citrus Springs, Florida 34434

**Article III - Purpose**

The general purpose for which the Corporation is organized is to conduct chartered fishing trips and any and all other lawful business for which Corporations may be incorporated under the Florida Business Corporation Act, the laws of the State of Florida and the United States of America.

**Article IV - Duration**

The duration of the Corporation is to be perpetual. The date and time of the corporate existence shall be at the time and date when these Articles of Incorporation are filed with the Secretary of State of the State of Florida, as evidenced by the Department of State's date and time endorsements on the original Articles of Incorporation.

**Article V - Capital Stock**

This Corporation is authorized to issue ONE HUNDRED (100) shares of One Dollar (\$1.00) par value common stock, which shall be designated "Common Shares."

**Article VI - Initial Registered Office and Agent**

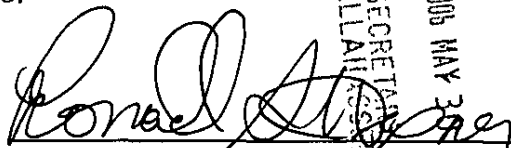
