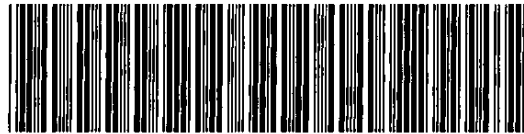

The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for - profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

**1. NAME**

The name of the Corporation is:

KMI Consulting, Inc.

**2. TERM OF EXISTENCE**

The date when the corporate existence shall commence shall be May 31, 2006, and the Corporation shall have perpetual existence thereafter.

**3. PURPOSE**

The purpose for which the Corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws, including the ownership and operation of real property.

**4. CAPITAL STOCK**

The initial Board of Directors shall have one member whose name and address is as follows:

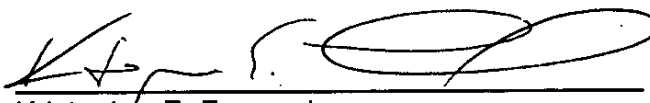

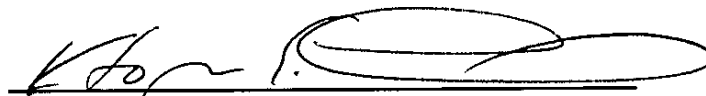
