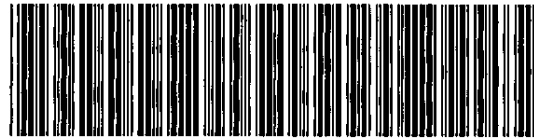



NAME


