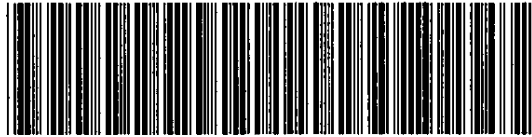

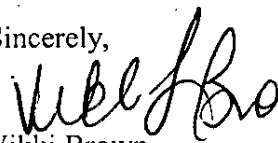

The undersigned hereby organizes a corporation for profit under the provisions of the Florida Professional Service Corporation Act, and pursuant to the following Articles of Incorporation.

**ARTICLE 1**

**Name**

The name of this corporation is: **SUSAN MYERS, P.A.**

**ARTICLE 2**

**Mailing Address**

**ARTICLE 3**

**CORPORATION PURPOSES, POWERS & RIGHTS**

The nature of the business to be conducted or promoted and the purposes of the corporation are to engage in the practice of real estate and any lawful act or activity for which a professional service corporation engaged in such profession may be organized under the Professional Service Corporation Act ("Act"), and in which such a corporation is permitted to engage under applicable law. 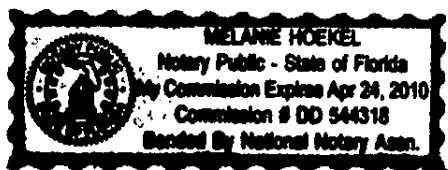
