ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: REIDBROWN ENTERPRISES, INC. The principal office of the Corporation and mailing address of the Corporation are 20 N. Orange Avenue, Suite 800, Orlando, Florida 32801.
 - Article 2. Duration, The duration of the Corporation is perpetual.
- <u>Article 3. Purpose.</u> The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.
