**ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation pursuant to chapter 607, Florida Statutes, adopt(s) the following Articles of incorporation of such corporation:

ARTICLES I – NAME AND PLACE OF BUSINESS

The name of the corporation shall be: Adreeynaline Entertainment Corporation

**The principal place of business of this corporation shall be: 7931 Versilia Drive,
Orlando, Florida, ZIP 32836.**

ARTICLES II – TERM OF EXISTENCE

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLES III – NATURE OF BUSSINESS

The rendition of any and all lawful business, especially those related to the management and promotion of artistic activities, in the areas of cinema, theatre and musical concerts, and all other categories of entertainment.

ARTICLES IV – CAPITAL STOCK


The maximum numbers of stock shares that this corporation is authorized to have outstanding at any one time are 2.500.000 shares of common stock having a nominal value of US\$1.00 per share.

ARTICLES V – INITIAL CAPITAL
