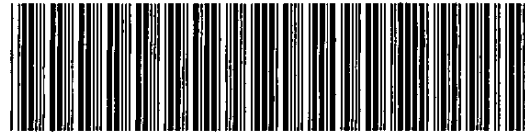



**Article IV - Authorized Capital**


