

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

**ARTICLE I- NAME AND ADDRESS OF CORPORATION**

The name of the corporation shall be TABLE TOP LINEN RENTAL, INC. The address of the corporation shall be 4669 L.B. McLeod Road, Suite F, Orlando, Florida 32811.


