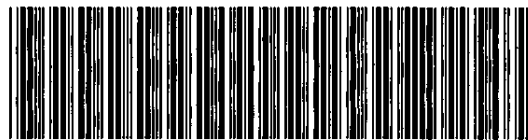

The undersigned subscribes to these Articles of Incorporation, each natural person, competent to contract, hereby associate themselves together to form a corporation for profit under the Laws of the state of Florida, and further do agree to the fallowing conditions of said corporation.

ARTICLE I

NAME AND ADDRESS

The name of this corporation shall be:

ARTICLE II

PURPOSE AND INITIAL BUSINESS

- 1- The nature of the business to be transacted, promoted or carried on by the Corporation are to engage in any awful act or activity for which corporations may be organized, under the Corporation Act of the State of Florida.
- 2- Organize and arrange every trade show such as publicity, advertising, radio, TV, graphic design, web pages, and all regarding with the media.

This Article shall not eliminate or limit the liability of a director for any act or omission occurring prior to the date on which this Article becomes effective.




