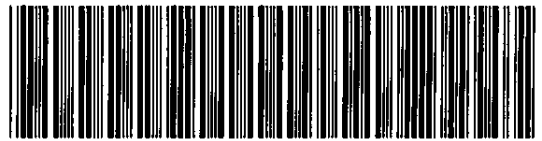

2. CAPITAL STOCK: The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is 500 shares of common stock having no par value.

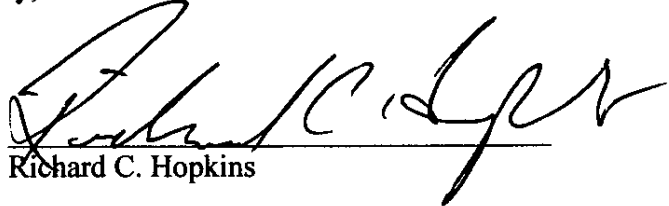

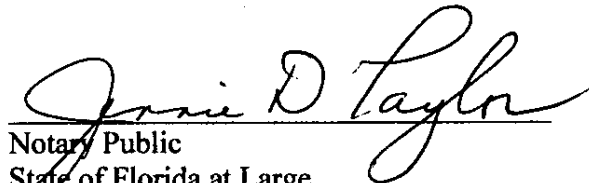
