The undersigned, **Judy R. Kostur**, acting as Incorporator and initial Director of a Corporation to be formed under the Florida Business Corporation Act, Chapter 607, Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

CORPORATE NAME AND ADDRESS

This Corporation will be known as and shall do business under the name of and at the following address:

ARTICLE II

DURATION AND COMMENCEMENT OF EXISTENCE

The duration of this Corporation is perpetual. The time of commencement of its existence is immediately.

ARTICLE III

PURPOSE, POWERS AND NATURE OF BUSINESS

The purpose of this Corporation is to engage in any and all lawful business for which corporations may be incorporated under the laws of the State of Florida or permitted under the laws of the United States. The Corporation shall have all of the general powers listed

in Section 607.0302, Florida Statutes, all of the emergency powers listed in Section 607.0303, Florida Statutes, and all other powers which are necessary, convenient or incidental to the express power or to conduct any and all business permitted under law.

AUTHORIZED SHARES OF STOCK

The Corporation is authorized to issue one thousand (1,000) shares of stock, all of one (1) class, having a par value of One Dollar (\$1.00) per share.

ARTICLE V

BOARD OF DIRECTORS

The initial Board of Directors shall consist of one (1) member. Directors shall be elected in accordance with the Bylaws.
