



ARTICLES OF INCORPORATION OF

ST. JOHNS COUNTY FISH & WILDLIFE ASSOCIATION, INC.

ARTICLE I - NAME

The name of this Corporation is ST. JOHNS COUNTY FISH & WILDLIFE ASSOCIATION, INC., and the principal business and mailing address of the Corporation is 5630 Old State Road 207, Elkton, Florida 32033.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence June 2, 2006. This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE
