### ARTICLES OF INCORPORATION ASSEE F OF BE NC (SE USA), INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is BE NC (SE USA) Inc. (the "Corporation").

# ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS
